Part 3 – Control Measures

First Aid Measures			
Inhalation	Unlikely route of exposure. Supply fresh air; consult doctor in case of complaints. Provide oxygen treatment if affected person has difficulty breathing.		
Ingestion	NEVER INDUCE VOMITING ; immediately call for medical help. Unlikely route of exposure. Rinse out mouth and then drink plenty of water.		
Skin Contact	Immediately wash with water and soap and rinse thoroughly. If skin irritation or rash occurs: seek medical advice/attention		
Eye Contact	Protect unharmed eye. Remove contact lenses if worn. Rinse opened eye for several minutes under running water. Then consult a doctor.		
Injection	Nil		
General	Immediately remove any clothing soiled by the product. Take affected persons out into the fresh air. Symptoms of poisoning may even occur after several hours; therefore medical observation for at least 48 hours after the accident.		
Fire Precautions	<p>Suitable extinguishing agents: Water fog / haze, foam, Carbon dioxide, gaseous extinguishing agents, fire-extinguishing powder.</p> <p>For safety reasons unsuitable extinguishing agents: Water stream.</p> <p>Special hazards arising from the substance or mixture: Danger of receptacles bursting because of high vapor pressure if heated. Cool endangered containers with water fog,</p>	Spillage (accidental release)	<p>Personal precautions, protective equipment and emergency procedures: Use respiratory protective device against the effects of fumes/dust/aerosol. Ensure adequate ventilation. Wear protective equipment. Keep unprotected persons away. Keep away from ignition sources. Protect from heat.</p> <p>Environmental precautions: Do not allow to enter sewers/ surface or ground water.</p> <p>Methods and material for containment and cleaning up: Allow to solidify. Pick up mechanically. Dispose contaminated material as waste according to item 13. Send for recovery or disposal in suitable receptacles.</p>
Handling	<p>Precautions for safe handling: Use only in well ventilated areas. Avoid splashes or spray in enclosed areas.</p> <p>Information about protection against explosions and fires: Keep ignition sources away - Do not smoke. Protect against electrostatic charges. Keep respiratory protective device available.</p> <p>Pressurised container: protect from sunlight and do not expose to temperatures exceeding 120 °F / 49 °C, i.e. electric lights. Do not pierce or burn, even after use. Do not spray on a naked flame or any incandescent material. Emergency cooling must be available in case of nearby fire.</p>	Storage	<p>Information about storage in one common storage facility: Store away from foodstuffs. Store away from oxidising agents. Further information about storage conditions: Do not expose to temperatures exceeding 50°C/122°F. Observe official regulations on storing packagings with pressurised containers. Provide ventilation for receptacles. Avoid storage near extreme heat, ignition sources or open flame.</p>
