<b>General</b>	<p><b>General information:</b> In case of accident, or if you feel unwell, seek medical advice (show the label where possible).</p> <p><b>Advice for Medical Doctors:</b> Brodifacoum is an indirect anti-coagulant. Phytomenadione, Vitamin K, is antidotal. Determine prothrombin time not less than 18 hours after consumption. If elevated, administer Vitamin K1 until prothrombin time normalises. Continue determination of prothrombin time for two weeks after withdrawal of antidote and resume treatment if elevation occurs in that time.</p>		
<b>Fire Precautions</b>	<p><b>Suitable extinguishing agents:</b> Keep fire exposed containers cool by spraying with water. Appropriate fire extinguishers are CO<sub>2</sub>, Powder or Alcohol resistant foam. Use extinguishing media appropriate to the surrounding conditions.</p> <p><b>Special hazards arising from the substance or mixture:</b> Formation of toxic gases may occur if heated such as carbon oxides, nitrogen oxides and hydrogen chloride gas.</p> <p><b>Protective equipment:</b> Wear self-contained respiratory protective device.
